Registration and Rules

Registration begins at 9:00 am, July 4th, if team-limit has not already been reached.
Young Memorial Park, Murray, Nebraska

These rules are subject to change at the discretion of the Freedom Festival Committee.

1. Minimum player age is 12 years.
2. Teams are limited to 26 – first come first serve. When team-limit is reached, it will be posted on website.
3. Registration Fee is \$80 per team with a maximum of 8 players per team.
4. Team captains will serve as a liaison between the players and organizers.
5. All players are required to wear shoes.
6. All team names must be family-friendly and politically correct. Organizers have the right to edit or change any team name.
7. No foul language or unsportsmanlike conduct will be tolerated. The committee reserves the right to remove any player for inappropriate behavior.
8. Captains must collect each player's completed, signed waiver and submit to the registration table prior to play. No waiver, no play.
9. Games will play to a score of 14, except the finals which will play to a score of 21.
10. Tournament will be double-elimination using regular tournament scoring and brackets.
11. Medals will be presented to the overall winning team.
